





CORFU SUMMER SCHOOL 2017

"Recent developments on European Business Law"

Content of the Summer School:

The summer course will provide participants with a practical approach of the recent developments - legislative and judicial - on European Business Law.

After a four-day intensive course, participants will have gained substantial knowledge on various aspects of European Union Law by learning from distinguished academics and judges at the Court of Justice of the European Union.

In the evenings participants will be free to enjoy and explore the attractions of Corfu, a splendid Greek island which is well-renowned for its historic city and its unique cultural identity.

When and where:

From Monday, July 24 (day of arrival), to Friday, July 28 2017. Courses will take place at the premises of the Ionian University, Corfu, Greece.

By who:

The summer course is an initiative of the European Law Masters Alumni Association (ELMAA) of the Law School of Athens and is co-organised by ELMAA, the Center of International and European Economic Law (CIEEL) and the Laboratory of Legal, Financial, Political and Technical Translation (ENOPOTEM) of the Ionian University of Corfu.

Who could attend:

Postgraduate law students and (trainee) lawyers who wish to advance their knowledge in the field of European Union Law. Undergraduate law students and individuals with a specialization in other scientific fields are also welcome, as long as they provide adequate evidence that they can actively involve and benefit from attending the courses.

As courses will be held in Greek and/or English, working level knowledge of both languages is essential.

Registration and participation fee:

Selected applicants will be informed via e-mail by late May. They will also receive an invitation to transfer the registration fee to ELMAA's bank account. Please note that participation will not be ensured until the fee is paid.

- 1) Registration fee: **160 Euros/person** <u>OR</u> (ELMAA's members): **110 Euros/person.** The fee covers a 5-night accommodation in the students' dormitory of the Ionian University (in double or triple rooms), breakfast, coffee breaks and lunch.
- 2) Early registration fee (until 20.5.2017): 130 Euros/person.
